General Terms & Conditions

- 1. These promotions are exclusive to Swing By @ Thomson Plaza.
- 2. Shoppers will need to download the M Malls mobile app and register as a member to qualify for any redemption.
- 3. Members are required to present their member QR code at the point of transaction and ensure transactions have been captured in their member account to qualify.
- 4. A minimum spend of \$20 per receipt is required for accumulation of points.
- 5. 1.5x spending required if Supermarket receipts are used for the redemption.
- 6. Receipts can only be used for 1 promotion tier each.
- 7. Limited to one (1) redemption per shopper per tier per day, regardless of total spending.
- 8. Redemptions are subjected to a daily cap per participating mall on a first-come, first-served basis while stocks last.
- 9. Redemption must be made in person on the same day of purchase at the L1 Redemption Counter (beside The Whisky Distillery).

- 11. No combination of purchases across accounts allowed. Spending transactions have to be credited to the same account.
